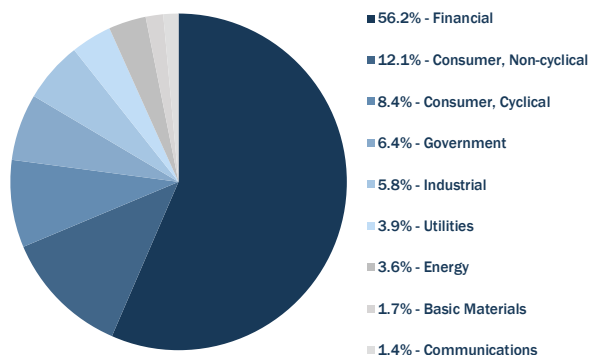

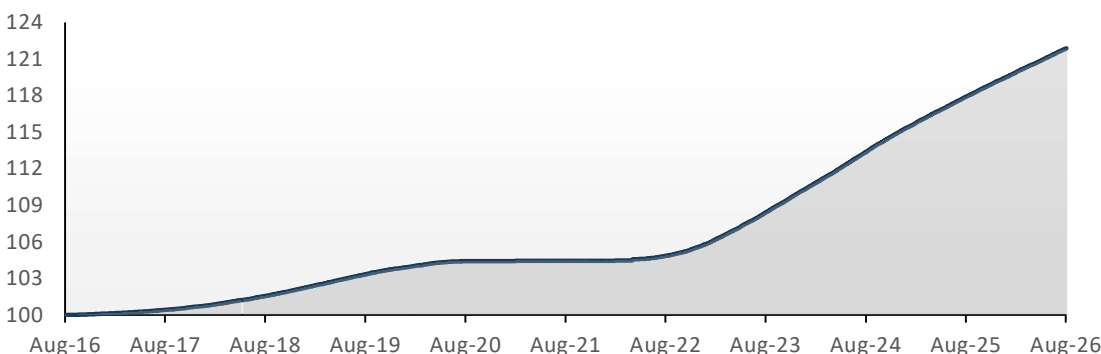
Strategic Asset Allocation
